Committee Meetings

Persons wishing to make public comment on agenda items were required to register prior to the start of tonight's meeting. If any current CBSD students registered to speak, they will be permitted to do so first. Please note that public comment during committee meetings is limited to agenda items only and is not intended to be a question-and-answer session. If your comments are not about agenda items, you will be asked to cease your comments. If a question is posed, the individual may be referred to the superintendent for follow-up.

When your name is called, please approach the podium and begin by stating your name and municipality. Each speaker is allotted three minutes; you will be asked to cease your comments at three minutes. We kindly ask that all comments be directed to the committee as a whole, rather than to individual committee members.

We appreciate your cooperation in maintaining a respectful environment. Please be considerate of all speakers and their opinions, including those that differ from your own. Thank you for your understanding.

Regular Board Meetings - First Period of Public Comment: Agenda Items Only

Persons wishing to make public comment were required to register prior to the start of tonight's meeting. If current CB students registered to speak, they will be permitted to do so first. Please note that the first period of public comment is for agenda items only, except for our students, who may speak about any topic. Public comment is not intended to be a question-and-answer session. When you begin your comment, please indicate which item(s) you are speaking about. Regarding the minutes that appear on the agenda, comment is limited to approval of the minutes, not their content. If your comments are not about agenda items, you will be asked to stop speaking, and you will be permitted to speak during the second period of public comment. If a question is posed, the individual may be referred to the Superintendent for follow-up.
