Central Bucks School District School Board Briefs December 2, 2024

At the December 2, 2024 School Board Meeting, the Central Bucks Board of School Directors:

Announced that the Board met in Executive Session this evening prior to the reorganization meeting for 30-minutes regarding potential litigation relating to pending investigations by the US Department of Education's Office for Civil Rights.

Heard Superintendent's Report:

Recognitions: Dr. Yanni recognized Unami Middle School student Caitlyn Lee for her original design for the December lock screen contest. Caitlyn's artwork was based on this month's Portrait of a Graduate attribute "Resilient Learners".

Remarks: Dr. Yanni discussed School Board Policy 903, now in effect, which includes two sections for public comment at school board meetings; the first period will pertain to agenda items, and the second period will not be limited to agenda items. The policy no longer includes language regarding yielding speaking time, and each speaker will have three minutes to address the board.

Dr. Yanni shared the rebranding of committees: the curriculum committee will now be named the education committee and the business & operational support services committee will be named the finance and operations committee.

Dr. Yanni spoke about renovations for eight elementary schools, noting that tonight's agenda items about renovations do not include plans for Doyle, Linden, or Kutz Elementary Schools. Dr. Yanni plans to hold some informational Town Hall meetings about those three schools, and a decision is not expected about those three schools until May 2025. Dr. Yanni spoke about the Belonging survey, which had a student response rate of 95.13%, and more details will be shared in January or February.

Dr. Yanni spoke about the 2025-2026 district calendar, noting that the first day of school for students will be September 2nd and the last day for students is scheduled to be June 12th.

Dr. Yanni announced that school board and committee meetings will be held on Thursdays moving forward. Dr. Yanni wished everyone a happy holiday season.

- 5. Vonna DeArmond welcomed Mrs. Gibson and Mrs. Reynolds to their newly elected roles and spoke about public comment regarding the Doyle/Linden/Kutz school decisions, Title IX presentations, and biological boys in girls' sports.
